NO PURCHASE, PAYMENT, OR DONATION OF ANY KIND IS NECESSARY TO ENTER OR WIN. ALL ENTRIES (ALSO REFERRED TO HEREIN AS "TICKETS") INTO THE SWEEPSTAKES HAVE A CHANCE OF WINNING. A PURCHASE, PAYMENT, OR DONATION WILL NOT INCREASE THE CHANCES OF WINNING. VOID WHERE PROHIBITED. BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES TO BE BOUND BY THESE OFFICIAL RULES

Children's Cancer Research Fund 2026 Chasing a Cure ("Sweepstakes") to benefit Children's Cancer Research Fund is offered only in the United States excluding California and Puerto Rico, and is open only to legal residents of that jurisdiction, 18 years of age or older at the time of entry, or the age of majority in Entrant's local jurisdiction, if older, and is void where prohibited by law. The Sweepstakes begins on June 1, 2026 at 12:01am (Central Standard Time) and ends on October 31, 2026 at 3:00pm (Central Standard Time). The Sweepstakes is subject to all applicable federal, state, and local laws and regulations, and is VOID wherever prohibited or restricted by law. Some restrictions and conditions apply, please read these rules in their entirety.

Please note the arbitration provision set forth below, which requires, except where and to the extent prohibited by law, you to arbitrate any claims you may have against Sponsor on an individual basis. Arbitration on an individual basis means that you will not have, and you waive, the right for a judge or jury to decide your claims, and that you may not proceed in a class, consolidated, or representative capacity.

By participating in the Sweepstakes you agree to be bound by these Official Rules. Please read these Official Rules before entering the Sweepstakes. Failure to comply with these Official Rules may (in the sole discretion of Sponsor) result in disqualification from the Sweepstakes. You must meet the eligibility requirements and follow the Official Rules regarding participation as set forth here. Sponsor reserves the right to cancel, modify or suspend the Sweepstakes at any time in its sole discretion.

Sponsor: Children's Cancer Research Fund, 1650 W 82nd Street, Suite 400, Minneapolis, MN 55431 (referred to herein as "Sponsor").

The Website: The Children's Cancer Research Fund Chasing a Cure Sweepstakes website (www.chasingacureforkids.org) ("Website") details how eligible individuals (see restrictions below) can enter the Sweepstakes. The funds raised through the Sweepstakes will support Children's Cancer Research Fund ("Charity").

Eligibility: To be eligible to enter the Sweepstakes or be awarded the prize(s), a Participant must fully comply with these Official Rules and be a legal United States resident who is at least 18 years of age on the date of Entry, or the age of majority in Entrant's local jurisdiction, if older, and is void where prohibited by law. Employees, as well as their immediate family members (parents, children, siblings, spouse) and others living in their same household, whether related or not, of Children's Cancer Research Fund and the independent audit firm responsible for the Sweepstakes verification (if applicable) are not eligible to enter. Any Entry submitted by any ineligible person(s) will be void. Hereinafter, all such individuals not otherwise excluded shall be referred to herein as "Entrant(s)" or "Participant(s)."

A person cannot be an Entrant or Winner if such person is a person (a) with whom U.S. persons or entities are restricted from doing business under regulations of the Office of Foreign Asset Control ("OFAC") of the Department of the Treasury (including those named on OFAC's Specifically Designated and Blocked Persons List) or under any statute or executive order or (b) who is acting, directly or indirectly, for or on behalf of any such person. All federal, state, and local laws and regulations apply. Individuals will be required to provide valid identification and may be required to provide a valid taxpayer identification number or social security number to claim a prize. Unless otherwise stated within these Official Rules, all federal, state, and local taxes are the responsibility of the Winner.

Sweepstakes Period: The Sweepstakes Period will begin on June 1, 2026 at 12:01am (Central Standard Time) and end on October 31, 2026 at 3:00pm (Central Standard Time). ("Entry Period"). The Sweepstakes covers the below listed Prize.

How to enter: NO PAYMENT, PURCHASE, OR CONTRIBUTION NECESSARY TO ENTER. The Sweepstakes start and end time is as listed above, the Entry Period. Only those Entries received by Sponsor during the Entry Period will be valid. Sponsor will be the official timekeeper for the Sweepstakes.

The Sweepstakes will provide the following two (2) ways to enter:

1) *Donate and Enter.* To enter by the Donate and Enter method via the Website, visit the Website, click the "Enter" or "Enter Now" button from the Sweepstakes webpage. Then donate a minimum of \$50 USD and follow the instructions to provide your full, legal name, date of birth, mailing address, email address, daytime telephone number, and payment information and complete your donation. To enter The Donate and Enter method via mail, Entrants will write their full, legal name, date of birth, mailing address, email address, and daytime telephone number on a "3x5" card and mail in a business size #10 envelope with at least a \$50 USD donation in the form of check or money order to: Children's Cancer Research Fund, Attn: Chasing a Cure, 1650 W 82nd St., Suite 400 Minneapolis, MN 55431. Entries by mail must be received by Sponsor within the Entry Period. Upon Sponsor's receipt of the donation and confirmation of payment, a donor will automatically receive the quantity of Entries representing 2 times every 1 USD donated (ex: 100 entries for a \$50 USD donation) and be entered for that number of chances to win the Prize. Individuals may donate as many times as desired (if emailing, one submission per email), but a Participant is limited to the maximum Entry Limit (as defined below).

2) *Enter for Free.* = **NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN.** Eligible participants may obtain sweepstakes entries without making a donation by completing the Alternative Method of Entry (AMOE) process described below. Each separately emailed, valid AMOE form received in compliance with these Official Rules constitutes one (1) AMOE submission and will receive 100 sweepstakes entries.

Step 2: Complete the Form by Hand

The entrant must complete all required information and statements by hand. Mechanically reproduced, automated, bulk-generated, scripted, or computer-generated submissions may be disqualified.

Step 3: Prepare the Submission

All information on the AMOE form must be completed by hand by the entrant. Incomplete, illegible, altered, late, misdirected, or otherwise non-compliant submissions may be void.

Step 4: Email the Submission

- Limit: Only one (1) submission is permitted per email. Multiple submissions in a single email may be void.
- Deadlines: Must be electronically time stamped by 3pm CST on October 31, 2026

Step 5: Entry Processing & Confirmation

Upon receipt of a complete, legible, and valid AMOE submission, the entrant will receive 100 sweepstakes entries. AMOE submissions will not receive an individual confirmation of receipt, validation, or entry status unless otherwise required by law. Proof of emailing does not constitute proof of receipt. Sponsor reserves the right to determine the validity and eligibility of all submissions in its sole discretion and in accordance with these Official Rules.

Eligible entrants may submit up to 200 valid AMOE submissions for a maximum of 20,000 total sweepstakes entries per person during the Promotion Period.

Legal Disclaimer & Liability

Sponsor reserves the right to determine the validity and eligibility of all submissions in its sole discretion and in accordance with the Official Rules. Sponsor reserves the right to disqualify any entrant suspected of using automated systems, bulk submissions, fraudulent identities, scripted entry methods, or any attempt to circumvent the intended AMOE process. Sponsor is not responsible for lost, late, damaged, delayed, incomplete, misdirected, or postage-due mail. Entrants must meet all eligibility requirements described in these Official Rules. Void where prohibited..

Entry Limitations and Restrictions: Only accurate and complete Entries submitted during the Entry Period and received by Sponsor are eligible. Any incomplete, illegible, corrupted, or untimely Entries are also void and ineligible to win. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, stolen, illegible, incomplete, invalid, unintelligible, misdirected, damaged, destroyed, technically corrupted or garbled Entries, or for other submission problems of any kind, whether caused by mechanical, human, or electronic error. Additionally, Sponsor is not responsible for any telephone, electronic, hardware, software, network, Internet, or computer malfunctions, failures, or difficulties. If a Participant's donation is refunded or cancelled (whether through insufficient funds, failed credit card information, etc.), then any Entries associated with such donation will be withdrawn and not eligible to win. All Entries become the sole property of Children's Cancer Research Fund and will not be returned.

Entry Limit: The maximum number of Entries for any one person into this Sweepstakes (the "Entry Limit") is 20,000 regardless of the method of entry.

Required Information: Participants must provide all required information specified on the Sweepstake's page or Entry form to be eligible to enter and win.

Email Address Requirements. Participants may not use multiple email addresses, identities, address, logins, devices, or any other tactics used in an effort to receive Entries over the Sweepstake's Entry Limit. To receive valid Entries, Participant must provide a valid email address for which the Participant is the authorized owner. Multiple Participants may not share the same email address. In the event of a dispute as to the identity of any Participant, the authorized account holder of the email address used to enter will be deemed to be the Participant. The "authorized account holder" is the natural person assigned an email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential Winners and/or Winners (as defined below) may be required to show proof of being the authorized account holder. Any Entries connected to an invalid, non-working, or inactive email address, or linked to an authorized account holder other than Participant, are void and ineligible to win. Any conduct in violation of this Section is strictly prohibited and will void *all* Entries for that Participant and may result in disqualification of Participant from the Sweepstakes, at Sponsor's discretion.

No Automated Entry Devices: All Entries must be submitted by the individual Participant to be valid. Use, or attempted use, of any robotic, automated, programmed, mechanical, or other non-manual Entry methods will void *all* Entries for that Participant and will result in disqualification of the Participant from the Sweepstakes, at Sponsor's discretion. Sponsor has the sole right and discretion to decide that Participant used or attempted to use any such prohibited automated Entry methods.

By entering the Sweepstakes, you agree that Sponsor may contact you via email, phone, and mail in accordance with Sponsor's Privacy Policy, available at the sponsor privacy policy link included in this document.

Media Release

Except where prohibited by law, by accepting a Prize, each winner grants to Sponsor and its affiliates, successors, assigns, licensees, and designees the irrevocable right and permission the right to use the Winner's name, photograph, likeness, and city and state of residence for advertising, publicity, or promotional purposes.

Winner Drawings: Winners will be randomly drawn from among all eligible Entries received. The drawing will occur on or after the end of the Entry Period. Sponsor, with an independent auditing firm, will conduct the drawing and awarding of the Prizes. Once confirmed and verified as eligible to win, a Potential Winner is referred to herein as a "Winner."

Odds of Winning: The odds of winning depend on the number of eligible Entries received during the Entry Period.

Prize: There will be one (1) Winner that will receive all of the following Prizes. Sponsor will award one (1) Rookie of the Year Ikon boat "as is, where is and with all faults" ("Boat" or "Boat Prize") accompanied by a Boat Mate Deluxe Trailer. Hereinafter, the Boat and Trailer shall be referred to as Prize. The Approximate Retail Value ("ARV") of the Boat and Trailer Prize is \$160,000. Sponsor will award hotel accommodation for two (2) nights in Charlotte, North Carolina (hotel to be determined by Sponsor: one double occupancy room and room tax only). The ARV of the hotel accommodation is \$1,000. Sponsor will reimburse the Winner and one guest of Winner for airfare costs up to a maximum of \$2,000 after Winner provides Sponsor with proof of payment for said airfare. The ARV of the airfare is \$2,000. The actual retail value of the prizes may vary depending on fare fluctuations and other variables. Any difference between the actual retail value of prize and the approximate retail value of the prizes will not be awarded.

Sponsor does not make or provide any representation, guarantee, or warranty, expressed or implied, in connection with the Boat or Trailer and accepts no liability or responsibility regarding the construction or condition of the Boat or Trailer. Sponsor does not warrant that the Boat or Trailer are of mercantile quality or that they can be used for any particular purpose. No express warranties are given and no affirmation of Sponsor by words and/or actions will constitute a warranty. Winner will receive a phone call with notification that they have won. Sponsor shall make three phone call attempts to notify the winner. After the three calls have been made a certified letter will be sent to the Winner via USPS. After the letter is sent, the Winner must claim prize within thirty (30) business days of the date written on the letter or a new winner will be selected.

The Sponsor will determine when the trip must be fully executed or the prizes will be forfeited. Certain blackout dates and material restrictions may apply. No

Award of Prize: On October 31, 2026, the Winner will be notified by telephone and/or by certified letter from Children's Cancer Research Fund and will be required to execute and return a declaration of eligibility, a liability release, and, if applicable, other information for travel arrangements within fourteen (14) business days of claiming a Prize. By accepting the Prize, except where prohibited by law, Winner agrees to the use of his or her name and/or photograph for advertising/publicity purposes without further compensation or notice. Prior to receiving any Prizes, a Winner must prove their identity and complete applicable Internal Revenue Service (IRS) Tax Forms.
